22/002 CO-OPTION

Council decided unanimously to co-opt Krystyna Sochacki. (Prop: JB, Sec: MD)

22/003 PUBLIC PARTICIPATION SESSION – None.

22/004 DECLARATIONS OF INTEREST – None.

22/005 MINUTES – It was agreed that the Chairman should sign the minutes of 11th November 2021 as a true and correct record of the meeting.

22/006 REPORT FROM CLLR. LEZLEY PICTION (SHROPSHIRE COUNCIL)

See separate report.

Main points - SC has worked hard alongside the NHS on the vaccine booster rollout, resulting in 83% take up – one of the best in the UK. Continued hand washing, face coverings and proper ventilation are advised to slow the spread of the virus. SC preparing to increase Council Tax by 3.99%, using reserves to balance the budget. North-West Relief Road is expected to go to Planning Committee in Feb/March. SC is investing almost £3m to make third wheelie bin available to residents, for plastic/metal/glass recycling.

AB commented that the new system for trade vehicles using the recycling depot is a great improvement.

22/007 OTHER REPORTS – None.

22/008 PROGRESS REPORT

- a) **SmartWater** Rollout is proceeding steadily. Quite a few kits were distributed at the Christmas Fair. **ACTION:** AB needs to register some kits online. Clerk to check numbers.
- b) **Broken streetlight** Insurance claim has been submitted. Response expected after 20th January. The task and finish group (AB, PR and SW) presented several quotes to the Council. Council agreed to go with the cheapest quote and that the repair should be actioned ASAP, not waiting for news from insurer, as it will need to be repaired regardless. **ACTION:** AB to instruct company to do repair. Clerk to inform Council as soon as insurers respond
- c) **UMPC laptop** Pending.
- d) Parking by Yew Tree Cottage Ongoing problem. Not much that can be done.
- e) **Blocked footpaths (Hunkington)** No reply or action taken. Clerk to report to SC and inform tenant by post.
- f) **Assets of Community Value** Both the Village Green (De Quincey Fields) and the Memorial Hall Field have now been registered for 5 years (no appeal).

22/009 GENERAL PARISH & HIGHWAY MATTERS

The Clerk recommended **fixmystreet.com** for reporting all sorts of maintenance issues. The exact location of a problem can be marked on a map, photos can be uploaded (recommended) and comments can be added to items previously reported. There seems to be a fairly swift registration of issues and prompt response from relevant department. **ACTION:** Clerk to publicise on website and Facebook.

22/010 PARISH PATHS PARTNERSHIP

Council decided that there was no need to set up a formal 3P group. An informal footpaths group met today. MD is happy to be their liaison with UMPC, to be formalised at the Annual PC Meeting in May.
