# Minutes of the Meeting of the Parish Council held on Thursday 13<sup>th</sup> July 2023 at 7.30pm in the Memorial Hall

#### 23/049 REGISTER OF ATTENDANCE and APOLOGIES FOR ABSENCE

#### 23/050 PUBLIC PARTICIPATION SESSION – None.

#### 23/051 DECLARATIONS OF INTEREST – None.

**23/052 MINUTES** – It was agreed that the Chairman should sign the minutes of the annual parish council meeting held on 11th May 2023, and the minutes of the Annual Community Meeting of the same date, as true and correct records of those meetings.

## 23/053 REPORT FROM CLLR. LEZLEY PICTON (SHROPSHIRE COUNCIL)

Cllr Picton reported that the unitary council is expected to survive its current financial challenges. SC has submitted its response to the Boundary Review (electoral) and has agreed that Tern Division should lose Bicton parish and gain Hadnall. The Local Plan is still undergoing examination – government decision expected around October time. Progress is being made with Highways jobs, focusing on the most desperately-needed repairs. Haughton road has been re-dressed and white lines painted.

#### 23/054 OTHER REPORTS

- a) **Footpaths** MD and HW reported that the footpath group has been working well with the Estate. No major issues at present.
- b) **SALC** PR had attended Chairs' Network Meeting on Zoom. He mentioned that the subject of AED inspections/maintenance had been a topic of discussion. He wondered whether the defibrillators in the village are being inspected and maintained. AED units will usually give an alert if there is any problem, but the

pads need to be checked to see if they are still in date. Councillors to speak informally to see whether this is being done by anyone.

#### 23/055 PROGRESS REPORT

- a) Village Hall fence This should be done as soon as harvest is finished (within 2 3 months).
- b) **Assets of Community Value** The Memorial Hall has been registered as an ACV for 5 years.
- c) **Asset inspection** AB has completed the inspection. Form to be sent to Clerk.
- d) **Damaged kerb by Yew Tree Cottage** JB reported that this has now been repaired.

#### 23/056 GENERAL PARISH & HIGHWAY MATTERS

Please note: Most highway and general repair matters are best reported using **fixmystreet.com**. This will usually get the quickest results.

**Holly Coppice road** – PR reported that the poor state of the road has been a subject of discussion on social media. Two potholes have been filled, but new ones keep appearing. The road is in a particularly bad condition under the trees close to the Haughmond Hill car park. Clerk to report to Highways and Cllr Picton.

**Church Lane** – JL reported her own and other residents' concerns about speeding. As the road is unadopted, it does not come under Shropshire Council Highways. JL agreed to discuss with residents how they want to proceed and if they require any action from the parish council, it will be an agenda item at a future meeting (if such action is within the parish council's powers).

**Highway signs** – JB and DS will do an inspection of all the signs and report back.

**Memorial Hall Wi-Fi** – Cllrs agreed that providing internet connection for village hall users would be hugely beneficial. AP to pass this on to the Hall Committee (who have already been in discussion about it).
