- a) **Double Yellow Lines – Haughmond Hill** – Update in Cty Cllr Report
- b) **Location of Tommys** – The decision to relocate Tommy’s cannot be discussed for six months.
- c) Agreed to publish Parish Council Meeting Minutes in Community News (proposed AF, seconded MD)
- d) Horton crossroads to Upton Magna will be resurfaced in 2026. Speed and access are also still an issue here. AF suggested rumble strips – to be addressed with Cty Cllr. A dilapidated shed belonging to the Forestry Commission also needs removing – Clerk to contact Forestry Commission regarding this and hedge trimming. Other local roads with poor surfaces are being resurfaced as a temporary solution.
- e) Communication – DC suggested a Community Whatsapp group to filter PC information to local residents, this could have a pinned post to advise of rules or be closed to responses. Clerk to write advert to go in Community News requesting details to AF of those who would like to join
