25/02 DECLARATIONS OF INTEREST – None.

25/03 PUBLIC SESSION – Huw Williams provided information on the new pathway, which will be up and running in April. A recent meeting with Councillors went well and further plans were made for the upkeep of pathways in Upton Magna

Members of the public asked for the location of the Tommy's to be reviewed based upon the following :- The fingerpost is the most googled and known location in Upton Magna, it is the most prominent of locations but is overcrowded with a planter, handrail, signpost and now Tommys. It was also requested that they shouldn't be a permanent display. It is thought the Church had offered for them to be sited on their land which may be more suitable. MOP also requested to know the cost of these, as the cost of living is rising and precept has been increased.

Members of the Public also raised the pending local elections which are contested, with four new nominations and that there is dissatisfaction amongst some residents within the village regarding the Public Session in March's meeting. Councillors are the elected representatives of the local community and should not assume to know how residents feel, residents felt they were not listened to.

- b) **Location of Tommys** – JB relayed how the original decision was reached. There has been no offer from the Church to site them on their land. After discussion it was decided to leave the Tommy's as a permanent feature as many villages also do this (VE day is in May too) and to de-clutter the Finger post area removing the handrail and footpath sign. Clerk to contact Shona Butler of pathways regarding this.
